Syntax is a sub-discipline of linguistics that studies the relationship between words in speech, including phrase structure, clause structure, and sentence structure in a language. Syntax refers to the set of rules that govern sentence structure in a language. It determines how words and phrases are arranged to form grammatically correct and meaningful sentences (Arifin, 2009:1). Syntax is the study of the rules governing the way words are combined to form sentences in a language. This science is centered on combining words to produce sentences in certain languages with correct grammar. Therefore, learning syntax can help students improve their understanding of the structure of English systematically, and students must have a good understanding of grammar and its units of words, phrases, and sentences to understand syntax.

Tree diagrams are a great method of understanding syntax. They are used in generative grammar as a means of displaying the internal hierarchical structure of sentences. Its advantage lies in showing the syntactic relationships between sentence units; moreover, functional relations are obviously described by this technique.

A noun phrase is a group of words that functions like a noun in a sentence and is part of syntax, the study of how words form phrases, clauses, sentences, and texts. It is a language construction consisting of a noun and other words such as adjectives, determiners, or prepositions that form a single unit that has a complete meaning. It is the basic structure in syntax and is commonly found in various sentences.

2. Tree Diagram

A tree diagram is a graphic representation of a sentence or expression's hierarchical structure based on formal grammar principles. Tree diagrams are used to illustrate how certain grammar rules can be utilized to examine and interpret texts or expressions. According to Shaden Shamel Abdullah (2020:573), "Generative grammar uses tree diagrams to show the internal hierarchical structure of sentences." It has the advantage of demonstrating the syntactic linkages between sentence parts; also, this technique clearly describes functional relations. Tree diagrams for noun phrases are the main topic of this study.
